BackyardCity.com warrants that your shade panel will arrive free from any defects in materials and workmanship under normal circumstances for 30 days from the time it is delivered. You should immediately open and inspect your items upon receipt. If you receive your order with a fault, defect or damage due to shipping, BackyardCity.com will issue a store credit or replace the damage or defective shade panels if you notify us via email to support@backyardcity.com with pictures of the box and the defect and provide an order or invoice number within thirty (30) days from the date of delivery defined by the shipping carrier's date of delivery. After this time, you assume responsibility for the item and any initial flaws or shipping damages.

It is manufactured using high quality ingredients that have been selected for their resistance to ultraviolet light degradation. The product is manufactured by Gale Pacific Limited ACN 082 263 778 ("Gale Pacific"), an ISO9002 accredited company. Gale Pacific Limited carries a 10-Year Warranty on Commercial 95 340 shade cloth for any defects or fabric degradation that leads to being unserviceable resulting from UV exposure.

Marine / Awning grade Sunbrella®

Sunbrella® awning grade fabric is a solution dyed acrylic high-quality canvas designed for outdoor use that is resistant to water, weather, and fading and is made by Glen Raven Mills, Inc. It is designed especially for UV rays defense, mildew and mold resistance, and easy cleaning. Glen Raven Mills, Inc. maintains a 10-Year Warranty on Sunbrella® fabric which protects against becoming unserviceable due to undue loss of color and loss of strength from normal usage and exposure conditions, including sunlight, mildew and atmospheric chemicals.

THIS WARRANTY IS SUBJECT TO THESE CONDITIONS AND PRODUCT CARE

• If the defect is contributed to or caused by any improper use of the SHADE PANEL or usage of the product for purposes other than that for which it was designed or intended.

- Damages or defects caused by poor designs like, but not limited to, exceeding grommet specifications, installing over sharp edges or allowing Shade Panel to chafe or rub on other objects.
- Your SHADE PANEL MUST be installed FIRM AND TIGHT to reduce wind flap in the shade fabric.
 SHADE PANELS that are loose and have wrinkles will cause premature failure due to mechanical breakdown. This is not considered a UV breakdown and is not covered by the warranty.
- The SHADE fabric requires periodic maintenance to ensure that the shade fabric remains tight.
- Your SHADE PANEL may become dirty over time. Care should be taken to avoid Chemicals that
 may contain Bleach, or other agricultural Chemicals containing Sulphur and or Halogens
 (chlorine, bromine, etc.). These Chemicals may attack the UV stabilizers within the fabric, thus
 reducing the Life of the product and negating the warranty.
- Many chemicals could damage your Shade Panel. Such chemicals may include pesticides, metals, metal oxides and metal salts, all halogens and chemical compounds containing halogens or sulfur in all their oxidation states. Care should be taken to avoid exposure to petrol, oils etc.
- When cleaning the SHADE PANEL, we recommend the use of a mild dish washing liquid with the use of a low-pressure water hose and a soft scrubbing brush. Do not use high-pressure water to blast the fabric clean.
- The Warranty does not cover damage caused by storms, hailstorm, earthquake, fire, lightning, or any other acts of GOD, mechanical damage done by birds, other animals, installation & handling carelessness and any form of vandalism or misuse.
- Your SHADE PANEL should be taken down and stored safely over the winter period if any snow
 accumulation is expected should always be taken down if tropical storm force conditions, or
 worse, are forecasted or in effect. If you remove the Shade Panel over winter, ensure that it is
 stored away from rats and mice, preferably stored in a protective bag.
- The warranty does not cover fading, loss of color, or a temporary cosmetic issue that doesn't impact the fabric's functionality or lifespan called "Crazing" which sometimes occurs with Sunbrella Awning grade fabrics.
